CLIFFORD HOLROYDE SCHOOL ACCESS PLAN

Following a recent review undertaken by the Headteacher of the existing Access Plan (2010 - 2011) and the Access Audit (by Dickinson Associates May 2003 for Liverpool City Council) a new plan has been formulated to encompass all facets of statutory requirements. The pupils at this School were Statemented for behavioural problems they are now Education Health & Care Plans (EHC).

Note; the school has not and is unlikely to have any future pupils or staff with mobility physical disabilities.

Statement on Equality Act 2010; "The Equality Act 2010 (which came into force in September 2011) has created a single equality duty, Clifford Holroyde School have a duty to provide a framework for our school to promote equality (including race, gender, age, disability, religion / belief, sexual orientation, marriage and civil partnerships), inclusion and effective community relations, and to tackle discrimination, prejudices and their causes in a proactive way." Race, Gender, Age, Disability, Religion / Belief, Sexual Orientation, marriage and civil partnerships are encompassed in Clifford Holroyde School's Policies.

The SEND Act 2001 and Part 3 of the Children and Families Act 2014 and particularly; The Special Educational Needs and Disability Regulations 2014 made under the Act are also considered in formulating the Access Plan

Access to the School Curriculum

In Place:

- All teachers and support staff have had the necessary training to teach and support disabled pupils. Staff training is ongoing.
- Almost all classrooms are optimally organised to cater for disabled pupils or would be if required.
- All lessons are suitably differentiated in order for all pupils to achieve,
- Teaching strategies allow for learning to take place and involve the pupils in tasks that can be achieved by the individual child, by the group and by the whole class
- All pupils are encouraged to take part in music, drama and PE.
- Staff recognise and allow for the additional time required for some pupils to use equipment in practical work.
- Teachers are very aware of the pupil's individual needs and do provide alternative activities for those children who cannot engage in particular activities.
- All school visits are open to all pupils irrespective of attainment or impairment
- All teachers have high expectations of all pupils.
- It is part of our Behaviour Policy that all staff seek to identify and remove any barriers to learning and participation that can hinder or exclude individual pupils
- The SENCo (Headteacher) liaises with outside agencies to seek help in providing other curricular opportunities outside of the National Curriculum to meet the needs of individuals, e.g. speech and language therapy and mobility training.

Further Development: see School Development Plan

- More staff training for children with specific disabilities if required
- Acquisition of more resources for disabled pupils, .e.g. software if required.

Access to the Physical Environment

- The layout and size of all areas on the Site does not allow access for all pupils, staff, and visitors however the 1st floor is the only area with major access restrictions. In the past 10 years art and music room extensions comply with modern accessibility requirements, other refurbishment & remodelling project works at the school considered accessibility in the design, e.g. the Front Entrance automated door and BS8300 compliant ramp.
- Wheelchairs cannot move about the school without experiencing barriers, however we
 will ensure full wheelchair access to all areas with the exception of the 1st floor if
 required.
- The provision of a passenger lift to allow total access to the 1st floor is not a priority for this school, at an estimated cost of £60,000.00 to be found from the delegated capital budget line this facility improvement will unlikely be attainable within the next five years.
- Until all building alterations / remodelling works are complete. If accessibility to any
 area is difficult for any pupil or staff member due to physical barriers the school will
 consider moving that class to an accessible area.
- Emergency and evacuation systems are in place, however alarms are only auditory except the Main Admin and AEP Learning Zone (sounder beacons). This will not be addressed in the near future.
- Ramps allow full access to most ground floor areas, however all the ramps do not meet current requirements. The main approach to the new Front Entrance is fully compliant to BS8300 recommendations.
- Décor tonal contrast and signage is now a primary consideration for refurbishment and remodelling works. This has been implemented for the facility during cyclical redecoration works.
- All areas, to which pupils have access, in both buildings, are well lit.
- Furniture and equipment is selected, adjusted and located appropriately. The access audit summary suggested improvements to the main entrance waiting area that is now complete. The Audit also suggested staff room furniture and general fixed furniture throughout the building be improved. Staffroom furniture has been addressed, classroom furniture has to be very durable due to the nature of the pupils and the balance of risks makes durability the highest priority.
- Accessible toilet facilities are provided in new Relocatable Building Extension. This facility is desirable in main building for visitors.
- Pathways of travel around the site that were stated in the original report as needing repairs to ensure safe passage (relaying of macadam surfaces, concrete hard standings & PCC paving) have been addressed
- Signage issues of concern have been addressed.

Further Development - See detailed plan

- Emergency systems may need to be visual or personal as well as auditory throughout the facility in the future. This will be addressed in future upgrading projects or when required for 'necessary adjustments'
- Provision of a Hearing Loop in the Main Reception, Headteacher's Office and the Assembly Hall, also provision of a portable hearing loop for other areas.

Access to Communication

In Place:

- All standard communications are in Ariel 12.
- The school offers information in alternative format can be lengthy process
- No staff are experienced with Type Talk.
- Coloured paper and overlays are used if there is a particular problem with reading.
- Larger text is or would be provided for those children with a visual impairment.
- We have Dyslexia Level 2 award

Further Development – see detailed plan

- Provision of information on audio tapes, in symbols or in Braille. if ever required.
- ICT provision to produce written information in different formats if required.
- CPD: staff to be more familiar with technology and practices developed to assist people with disabilities as required.
- Continuous evaluation of current requirements

Note; the School has access to Central Government's January 2015 document; the Special Educational Needs and Disability Code of Practice: 0 to 25 years - Statutory guidance for organisations which work with and support children and young people who have special educational needs or disabilities

Access Audit Report

The original Dickinson's Access Audit Report (2003) identified items required to improve access and resources needed to undertake improvements.

- Discreet audit of parents' disabilities, if any, to ensure they have full access to the facility (review of existing information)
- Complete rolling programme of LED replacement internal lighting
- An accessible toilet near the Reception Waiting area
- Provision of a Portable Hearing Loop

The Plan will be reviewed by the Governors (Building & Grounds Committee) to ascertain this replacement plan's effectiveness and any alterations required following that review.
